Section 3 - External Auditor Report and Certificate 2019/20

In respect of **Rustington Parish Council**

1 Respective responsibilities of the body and the auditor

This authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The authority prepares an Annual Governance and Accountability Return in accordance with *Proper Practices* which:

- summarises the accounting records for the year ended 31 March 2020; and
- confirms and provides assurance on those matters that are relevant to our duties and responsibilities as external auditors.

Our responsibility is to review Sections 1 and 2 of the Annual Governance and Accountability Return in accordance with guidance issued by the National Audit Office (NAO) on behalf of the Comptroller and Auditor General (see note below). Our work **does not** constitute an audit carried out in accordance with International Standards on Auditing (UK and Ireland) and **does not** provide the same level of assurance that such an audit would do.

2 External auditor report 2019/20

Except for the matter reported below on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return, in our opinion the information in Sections 1 and 2 of the Annual Governance and Accountability Return is in accordance with the Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Sections 1 and 2 of the Annual Governance and Accountability Return were again approved after the start of the period for electors' rights which is contrary to Regulation 12(3), of the Audit and Account Regulations 2015. The Council should take steps to ensure it follows the correct procedure in future

This matter was also noted in our report for the 2018/19 Annual Governance and Accountability Return. This indicates that the Council has not satisfied assertion 7 for the 2019-20 year as it has not taken appropriate action on all matters raised in reports from internal and external audit. This is a breach of proper practices and therefore the Council should have answered 'No' to this assertion in Section 1. The Council should note this before completing its 2020-21 Return to prevent any further reoccurrence.

The notice of conclusion of the 2019 audit was dated 1 October 2019 which was after the statutory deadline of 30 September 2019. The Accounts and Audit Regulations 2015, Regulation 13(2) requires that the information provided in this notice be published by the statutory deadline or an explanation posted as to why this has not been completed which was not done. The Council should have also therefore answered 'No' to Box 4 on Section 1 of the Return.
